### Pune woman runs marathon in navvari saree

Pune Mrunal Inamdar, a Pinkathon Pune Ambassador, has won accolades for completing a marathon in a pink navvari saree. She successfully completed the intercity run of 165 km from Pune to Mumbai in October, and in the last run of the month, organised by Pune Running Beyond Myself (PRBM), a city-based fitness event, she ran 15 km in a navvari saree."I want people to understand that there is no dress code to run. You can run in anything. I saw people running in branded track pants and felt there was a need to do something different," said Inamdar.

She added, "The saree has been an integral part of an Indian woman's life. A lot of women do not engage in sports because of the attire. I wanted to change this conception and spread a message in society."

### Ensure installation of **CCTV** cameras in all schools: Gujarat High Court to state

Ahmedabad Agency. The Gujarat High Court on Tuesday directed the state government to submit by June an affidavit that would include an undertaking ensuring that CCTV cameras would be installed in all government as well as private schools.

The order passed by a Division Bench headed by Acting Chief Justice Anant Dave, expected the state "to consider mechanism to be worked out for installation of CCTV cameras in all schools viz Government schools, grant-in--aid schools and private unaided schools, but recognised schools, at all levels and affidavit be filed in this regard by the next date of hearing," scheduled for June 17. The affidavit is also expected to include the state's detailed plan towards installation of the CCTV cameras, including budgetary provisions.

A PIL filed in 2017 had prayed that "all schools and colleges in the state" must be equipped with CCTV cameras so as to ensure safety of children. Nishith Joshi, representing the petitioner, said this has two-fold purpose. "One, to put a stop on paedophile activities and secondly to monitor classroom lectures, besides attendance of teachers and students."The state government had initially submitted that they're committed towards ensuring safety of children in schools, but had cited budgetary constraints to implement this. However, we had submitted that financial constraints can't come in the way of ensuring children's safety. Moreover, Delhi government has implemented this successfully. Central Board of Secondary Education too directed its affiliated schools to install CCTV cameras, which has been adhered to. If Delhi government can do it, CBSE schools can do it, why not Gujarat government? Article 39 (f) of the Constitution states that children are (to be) given opportunities and facilities to develop in a healthy manner," added Joshi. The PIL had also prayed for the respondent authorities "to regularly inspect the CCTV footage and submit a report to the State Government."In September 2017, when the PIL was filed, the petitioners had submitted that "none of the Government schools have made use of this affordable yet effective technology i.e. CCTV to ensure that children are not sexually abused and exploited. Moreover, the irregularity and indiscipline in conducting classrooms (sic) in schools and colleges is a burning issue.

### **Gujarat: Don't panic or** hoard water, we have enough till July end, says Vijay Rupani

network not been built in Gujarat, regions such as Saurashtra, Kutch and North Gujarat could have faced a serious shortage of drinking water this year, Chief Minister Vijay Rupani said Tuesday, assuring the public that there was sufficient water to supply drinking water till July 31 and therefore no need to hoard it.Addressing a press conference on Tuesday after holding a high-level meeting with top officials to review the availability of water in the state, Rupani said he had called the press meet to prevent misinformation from being spread. "If people panic, it would result in unnecessary hoarding of water. So, I am saying that the government is ready to provide water till July 31," Rupani said.

the state could have faced problems such as like large scale migration, Rupani said, "Due to the Narmada network, we have been able to provide water by drawing it from a distance of 500. The dams of Saurashtra were almost empty, but we have filled them with Narmada water and

Managing Director of Sardar Sarovar Narmada Nigam Limited (SSNNL) Rajiv Kumar Gupta told the press that on April 30 last year, the water level in Narmada dam had been 104.33 metre, whereas the water level today is 119.50 metre.

Chandigarh: 43 students attend workshop, think of ways to re-energise sectors

Chandigarh Agency. Forty-three chitkara University and Chandigarh College of Architecture took part in the workshop and idea competition on "Re-Organising the Building Block of Corbusian Legacy" on the CCA campus on Tuesday.It is an initiative under the Chandigarh Smart City Project to incorporate new design ideas in two selected sectors — 22 and 35. The budding architects are being encouraged to re-energise these sectors with features such as greens, cycleways, pathways and other spaces. The initial presentation by experts from NIUA and URBZ, who have worked in the field of architecture, anthropology and design research, shared their plan for redesigning parts of the city. The workshop for students will help young architects to focus on different segments and models to carve out new ideas. It included visit to the sectors, research work, taking inputs from local people, understanding urban interventions, working on child-friendly features, analysing basic problems, making an action plan and then designing a new model of the sectors."We cannot leave the city only for the architects to design in its best form. We follow a completely different pattern, where we speak directly to people to understand the difficulties they face on ground and then construct our designs. Our basic idea is to build as per the model — from sectors to neighbourhood. The job of an architect is not just to design a building or introduce a work of art, but also to make it successful and it is only possible when people understand its utility and use it in its best form," said Rahul Shrivastav, URBZ, anthropologist. "Chandigarh has always been very popular because of its unique architecture. There are many factors that make a city smart and one of the main pointers, which is usually missing in most cities is 'children friendly.

A woman bank officer who lodged an FIR against an employee of Himachal Pradesh Gramin Bank posted at Parwanoo for raping her on the pretext of marriage in February this year, has accused Panchkula police of not arresting the accused. She has accused the police of implicating her and her family members in false POCSO Act cases registered at Nalagarh, Pinjore and Panchkula. The victim lodged her complaint with senior police officers. She claims she is being pressured by the Panchkula police to take back her FIR against Manish Poonia, which was registered at the Sector 3 police station. The victim said a sister of accused Manish Poonia is a Subinspector with Panchkula police and posted with Women Police Station. One of the POCSO Act FIRs registered against the victim's mother and brother is being probed by the Women Police Station, Panchkula. However, ACP, Panchkula, Noopur Bishnoi said, "We are investigating one of the FIRs registered under POCSO Act



against the victim's mother and brother. The two are on anticipatory bail and joined the investigation. We are not pressuring anyone to take any FIR back against Manish Poonia. Manish's sister is with Panchkula police and she is on long leave. She is not posted in Woman Police Station. She is in police lines.'

According to the two FIRs — one registered against the rape victim at Nalagarh police station and the other against her relative at

Pinjore police station sexual assault took place in March 2018 but the two FIRs were registered in March this year. The FIR against the rape victim was registered at Nalagarh police station on March 26 this year. Another FIR against her mother and her brother was also registered on March 26 at Pinjore police station. The victim told Chandigarh Newsline, "Manish Poonia and I came in contact with each other through a matrimonial site 'Shaadi.com' in August 2017.

Manish had uploaded his profile introducing himself as unmarried. We started liking each other. He promised to marry me and made physical relations with me. Our family members started interacting with one another. But when things came to marriage, Manish retracted and later disclosed that he is already married and a divorce suit is pending between him and his wife. Chandigarh Police did not lodge an FIR. Then I approached the court, which directed the police to lodge an FIR against Manish Poonia at Sector 3 police station in February 2019. But in March, two FIRs under POCSO Act were registered against me and my family members at Nalagarh and Pinjore."DSP, central, Krishan Kumar said, "The FIR against Manish Poonia is under investigation. The opposite party is also levelling allegations against the complainant. It is a sensitive matter. We are not shielding anyone. Manish Poonia had appeared during the course of investigation. A woman officer is probing the case."

# Immigration firms booked for cheating continue to figure on Mohali website, DC vows action

Mohali Agency. The long list of registered immigration companies on the Mohali administration's website evokes trust. But Newsline found even the agencies booked for dubious dealings continue to figure on the website, thereby defeating its very purpose. One of the firms, for instance, has 58 cases against it, yet it continues to feature on the administration website. As many as 58 cases are registered against The World Key Immigration firm, yet the authorities are yet to strike its name off. Cheating cases have also been registered against Seabird and Unicorn Overseas in Phase 10, which continue to be among agencies listed on the website.Even as the Mohali police carried out 50 raids in frauds related to immigration last month, people continue getting duped in the name of foreign

The arrest of three women, who were part of a gang duping people in the name of contract marriage for immigration, put the spotlight on the proliferation of immigration-related frauds in Mohali district. Over the years, Mohali has become a hub of immigration business with as many as 288 immigration firms registered with the district administration. Activists working against fraudulent immigration firms allege there are around 100 more firms running without any registration.Last month, some people carried out a protest against an immigration firm in Phase 3B2. On Tuesday, a dozen people met Senior Superintendent Police Harcharan Singh Bhullar and demanded registration of a case against the owners of an immigration

company that had taken money from them but had done nothing to keep its promise. Satnam Daun, who has been crusading against such illegal firms, told Chandigarh Newsline that fly-bynight operators are using the registration as a tool to dupe people. 'It gives them the government's stamp of approval and hapless people get taken in by it." Advocate Tejinder Singh Sidhu, who has been handling a number of immigration frauds, says when the government blacklists an immigration firm, the owners get another one registered under a different name and carry on their business.

"The registration is done only for consultancy, but these people start applying for visas, and then they ask the applicants to deposit some money, a part of which is non-refundable. Suppose an applicant

deposits Rs 1 lakh, these firms take 20 per cent as fees, which is non-refundable, even though the government frowns on this practice," advocate Tejinder Sidhu told Newsline. Sidhu claims in case of fraud by a registered firm, it is the liability of the government to refund the money. For registering a travel and immigration firm,

the owners have to deposit a fee of Rs 25,000 with the application form. The registration is done after police verification of the owner and the address where the firm is to be opened. The licence is issued under Punjab Travel Professionals Regulation Act.Mohali SSP Bhullar says he has directed all the Station House Officers to register cases against the travel agents who dupe people and arrest them. # Unable to have baby, woman kills neighbour, pulls out foetus

The foetus that Ravinder Kaur (40), a native of village Kala Nangal in **Gurdaspur's Batala** area, pulled out

Amritsar | Failing to conceive following tubectomy, a woman strangulated to death a neighbour who was seven months pregnant, cut open her womb and pulled out the foetus, all on the directions of a local 'witchdoctor' at a village in Punjab's Gurdaspur district. The foetus that Ravinder Kaur



(40), a native of village Kala Nangal in Gurdaspur's Batala area, pulled out hoping to bring it up as her own, died within minutes. She, with the help from her husband and others in the family, buried the foetus in their residential premises. The body of the victim woman, identified as Jasbir Kaur (32) of the same village, was kept in box and was to be disposed of later.

It was only after Jasbir's husband, Balwinder Singh, lodged a missing complaint at the local police station that the crime came to fore. Jasbir had gone missing on April 27 and was murdered the same day. Her body was found Tuesday.

Based on the husband's complaint police lodged an FIR under sections 302, 313, 316, 201 and 120(B) of IPC against Ravinder Kaur, her husband Gurpreet Singh, latter's parents Puran Singh and Joginder Kaur, and his sisters Nittu Kaur and Aman Kaur. The witchdoctor. identified by single name Deeso, was also booked under same

sections, said DSP Balbir Singh. As per the preliminary investigation, Ravinder Kaur, a divorcee, had married Gurpret four years ago. She had four children from her first marriage. Her children live with her first husband. She had also gone through tubectomy before getting divorced. Ravinder Kaur met Deeso who suggested she kill a pregnant woman and claim the foetus as her own child. The woman invited her neighbour Jasbir Kaur, who was expecting her first child, home where she was allegedly strangled her to death, police said. DSP Balbir Singh said they have already arrested five of the seven

accused.
