Lucknow. Ayodhya became a hotbed of politics Tuesday with Chief Minister Yogi Adityanath choosing to begin his speech in Chhattisgarh by telling people he has come from the birthplace of Ram, while former VHP leader Pravin Togadia announced in the city that he would soon launch his own political party. Meanwhile, Shiv Sena MP Sanjay Raut too reached Ayodhya to make preparations for a visit by party chief Uddhav Thackeray.

Thackeray had recently said in Mumbai that the BJP should either build a Ram temple or admit that it was all a gimmick.

Anil Singh, state president of the Shiv Sena, said, "On October 25, Uddhav ji will first visit Ram Lalla and offer his prayers. He will then

meet priests who are raising their voices for the construction of a Ram temple. He will then address a gathering of supporters at Saryu Ghat." Asked if their party had taken the permission for the meeting, he said they have submitted an application with the district administration.

"He (Raut) met party workers here in Ayodhya today, visited different temples and met priests. He had met the chief minister as well. After interacting with workers and attending the Saryu Arti in the evening, he will leave for Delhi," Singh told The Indian
