

Released after 20 years this man wants to go back to jail

Bastadi (Uttarakhand): After more than two decades in prison, a man likely to be excited to go back to home. But not Pushkar Bhatt.

Nearly 20 years ago, Bhatt was imprisoned for murdering his daughter in a fit of rage. He was released from Uttarakhand's Sitarganj prison completing his term. But Bhatt prepared for the situation that confronted after 20 years in prison. When I returned my village had been ruined in a disaster. Now no inhabitants live here. Bhatt. Once a beautiful little hamlet was at the centre of the 2016 Uttarakhand cloudburst that killed several people. "I have nothing to do, I feel scared," he said, adding that it feels like a ghost town. An unprecedented case, Bhatt appealed to administration to put him behind bars once again. After spending six years in this lonely village, Bhatt now says he can't take the loneliness anymore. In 2017, a court-based homeless man reportedly robbed a woman so he could go back to prison. When the judge told him he wanted to wake up in bed.
