70,000 jabs daily because of a shortage of vaccines. If we get enough supply, we have the capacity to inoculate 3 lakh people daily in Delhi." The chief minister said he is in constant touch with the central government and hoped that Delhi and other states will get enough vaccine doses to scale up the ongoing drive. This comes on a day when the Centre said that more than 31 million unutilised vaccine doses are still available with states and union territories. The Union health ministry said that 487.8 million vaccine doses have been provided to states and UTs so far through all sources and further 68,57,590 doses are in the pipeline. Of this, the total consumption including wastage is 45,82,60,052 doses. The Delhi government, meanwhile, is trying to push ahead with its vaccination drive through various innovative strategies. It has started a free pick up and drop off bus service leading to different schools turned into vaccination centres.
